It hasn't been easy, I have to admit, but the sense of achievement that I've got from this has outweighed any difficulties I've had to get through and overcome.






# What is the difference between a driving test and an EPA (End Point Assessment)?

It is not a trick question! There isn't a difference. An End Point Assessment (EPA) is just like any other exam.

Time is spent preparing for the test by learning practical skills and theory and then on a set day an examiner, in this case, an external assessor, will check your learning. Whilst the apprentice is learning just like a learner driver they are gaining valuable experience!

#### Hear from our Learners

We caught up with some past KEITS learners to see how their apprenticeship helped them achieve their goals and to tell us what they are up to now!

#### Leah Collins told us:

"After deciding I wanted to start dog grooming in April 2022 I started my apprenticeship with KEITS. Over the past 12 months I have learned how to properly prep and groom a dog, this includes bathing, drying, nail trims, clipping and scissoring. I have also learnt a lot during my online theory sessions, such as the different coat types and the type of grooming these require. I also learnt about the legislation that is important to a dog groomer, such as the Animal Welfare Act and what to do if an accident happens at work. During my apprenticeship I developed my confidence in dealing with customers and also grooming dogs.

I now work full time at Four Paws Lymm Ltd and I am working towards completing my level 3 diploma in dog grooming and salon management.

I passed my level 2 dog grooming apprenticeship in June 2023 with a distinction"



"I started my apprenticeship in March 2022. When I first started the apprenticeship I was very shy and nervous, but over the time spent in the salon and completing my apprenticeship my confidence has grown tremendously. I have learned so many new skills such as how to deal with customers, completed grooms on technical grooms and learned so much about the grooming industry. I really enjoyed my apprenticeship and it has given me a great stepping stone into my future. I am now fully qualified in dog grooming, as I completed my level 2 apprenticeship and the apprenticeship has lead me to complete my level 3 diploma in dog grooming. I now work full time as a dog groomer and I'm loving every minute of it!"
